Last January, The Salvation Army Kuching Corps Community Services received news that a house in a kampung in Kota Samarahan was destroyed by a fire.

There were 9 people who resided in the house (two children, one senior citizen and 6 adults), and one adult who needed hospital treatment due to the incident.

The team sprung into action and distributed fresh vegetables and fruits, dry grocery items, stationery, toiletries and clothing to the affected family members. Kuching Food Aid, another local NGO, donated mattresses and pillows which the team helped to deliver.

A local leader has pledged to help the family rebuild their home within the next three months. In the meantime, we hope the assistance rendered to the family of 9 will help ease their burden.

Update on the Kota Samarahan Project

Our Kuching team is ready to serve the Sarawak community at a greater scale, with the soon-to-be-launched of our new Kota Samarahan home by the end of 2023.

The building will occupy a 7.5 acre site with a 60-year lease allocated by the state government through the Unit for Other Religions (Unifor).

The building costs RM15.5 million, of which Unifor has allocated a grant worth RM4 million to assist in its construction and Borneo Medical Centre donated RM2.6 million to start the ball rolling for the project.

The Inland Revenue Board (Lembaga Hasil Dalam Negeri or LHDN) has recently issued the revised <u>Guidelines for Application Of Approval Under Subsection 44(6) Of The Income Tax Act 1967</u> (dated 15 May 2019). According to the document, organisations are now required to only issue official tax exemption receipts for donors who provide the following particulars:

- Donor's full name as per NRIC / passport / business registration
- NRIC number / passport number / business registration number
- Complete mailing address of current residence / business location

When replying to us, please provide the above information to enjoy the benefits of your tax-exempt receipt. Thank you and we value your support.
